## **ALL-STAR TEAMS**

Dear Parents,

Your Son or Daughter will be participating in one of our Competitive All-Star Teams at Ridgecrest. In order to participate on these teams, the student Athlete is responsible for the following:

1. The Student Athlete must have a **grade of C- or better and no U's in any of his/her classes**. If the Student Athletes grade drops below a C- or citizenship grade falls to a "U" during a grade check period, the Student Athlete will be on Probation from the Team. We will have a grade check at the beginning of the season and one halfway through the season. The student can practice but cannot play games if on probation. If the student is on probation at the beginning of the season, they will remain on probation until the second-grade check. If the student is on probation during the second-grade check, they will stay on probation until the end of the season.
2. To help defer costs for referees, coaches, buses, uniforms, equipment and other essentials, we ask that each participating student donate the fees stated below. Payments can be made through "Member Planet". A link can be found by going to the RIS website, click on the "Booster Clubs" tab, and scroll to the appropriate Team Flyer. **Booster Club Members: \$175** (Note: Participation Fee is not Tax Deductible and no refunds once payment is made)
3. Students must turn in the signed **Bus Form Travel Form(s), Bus Etiquette form and Grade Verification Form by the first game. Payment is also required before the first game**

The undersigned does for him/herself, his/her heirs, executors, administrators and assigns hereby release, waive discharge and relinquish any action or cause of action, which may hereafter arise for him/herself and for his/her estate and agrees that under no circumstances will he/she or his/her heirs, executors, administrators and assigns prosecute, present any claim or personal injury, bodily injury, property damage or wrongful death against the Palos Verdes Peninsula Unified School District, its Board, or any officers, agents, servants, or employees for any of said causes of action. 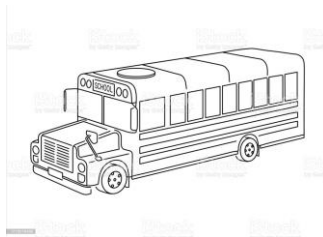

## Bus Etiquette



When we travel to Away Games, there will be NO-TOLERANCE Rules that apply to Behavior on the Bus. The Following Rules will be implemented on the Bus:

2. Always stay Seated

5. NO Food or Drink
6. NO Gestures or Yelling out the Window at Pedestrians or Cars
