Dear Parents,

Your Son or Daughter will be participating in one of our Competitive All-Star Teams at Ridgecrest. In order to participate on these teams, the student Athlete is responsible for the following:

- 1. The Student Athlete must have a grade of C- or better and no U's in any of his/her classes. If the Student Athletes grade drops below a C- or citizenship grade falls to a "U" during a grade check period, the Student Athlete will be on Probation from the Team. We will have a grade check at the beginning of the season and one halfway through the season. The student can practice but cannot play games if on probation. If the student is on probation at the beginning of the season, they will remain on probation until the second-grade check. If the student is on probation during the second-grade check, they will stay on probation until the end of the season.


